Sexton Report

- 1. Ron informed us that 2 people were buried since the last report (Darlene Schurr and Gary Lounsberry).
- 2. Three headstones and one headstone repaired this month. Information included.
- 3. Vera Buckley (cremation) will be buried October 11th.
- 4. JoAnne White made a motion to accept the sexton report, seconded by Tristen Woodruff. Carried by all present.

Treasurer's Report

- 1. Tristen's Treasurer's Report #7 is included.
- 2. Tristen shared the Income/Expenses from August 20th to September 24th, 2025. These are included.
- 3. Tristen mentioned that he paid double for the Johnny on the Spot, but it will be credited toward the next month.
- 4. Tristen accidently forgot to put a stamp on the Erie Insurance payment for Worker's Comp from last report, so it bounced. They sent a notice that they will deactivate our insurance if we don't make the payment by the middle of October. Tristen assured us that he sent the letter (with a stamp) in plenty of time. He will report next meeting.
- 5. Tristen reported that the Quickbooks and bank accounts are off a little. He will look into it and report at the next meeting.

- 6. The form 941 and NYS45 is due on October 15th, 2025.
- 7. Dennis White made a motion to accept the treasurer's report seconded by Lou Ann Slocum. Carried by all present.

Old Business

- 1. Dan Lounsberry reported that the Sloppy Joe dinner at the Scio Community Building is all set for October 15th. The building will be opened the day of the dinner at 2:00 to prepare the food.
- 2. The Sloppy Joe tickets will be turned in at the October 8th meeting at 5:30 for a final count. The committee will also be discussing the dinner preparations.
- 3. Dan mentioned that his daughter (Michelle) will give us a price on cabbage, ground beef (per pound), salt potatoes, and hamburger buns from Beefeaters in Bradford. We will also have to get onions, relish, take-out trays, napkins, and plastic utensils. We already have 9 pounds of ground beef.

New Business

- 1. The committee discussed putting \$3,000 to \$4,000 from the cemetery checking account into a money market account to get better interest. There was concern with the committee members because 2 more trees need to be cut down in the cemetery. This will be discussed again towards the end of the year.
- 2. The committee also discussed a recruitment campaign to get younger trustees and a potential president. We decided it would be worthwhile to have Michel Catena come down sometime in March to help us with recruitment.
- 3. It was decided that Appeal Letters would be sent out next year (every other year).
- 4. A quick meeting (to turn in the sloppy joe tickets) is scheduled for Friday, September 8th, 2025 at Dan Lounsberry's home at 5:30pm.
- 5. Motion to adjourn the meeting at 6:50pm was made by JoeAnne White, seconded by Tristen Woodruff. Carried by all present.
